## REGULAR CITY COUNCIL MEETING MINUTES APRIL 05, 2021, 6:00 P.M. CITY COUNCIL CHAMBERS

The City Council of Newton, Iowa met in regular session at 6:00 P.M. on the above date in the Council Chambers at 101 West 4<sup>th</sup> Street South and via an electronic meeting (pursuant to Iowa Code section 21.8) because a meeting in person is impossible or impractical due to concerns for the health and safety of council members, staff, and the public due to COVID-19. Mayor Hansen asked everyone present to join in saying the Pledge of Allegiance.

During staff reports, Brian Dunkelberger, City Planner, did an overview on the Community Development Residential Rental Inspection Program.

Fire Chief, Jarrod Wellik, discussed the Covid-19 Task Force recommendations for moving towards bringing the council meetings back to "normal" while keeping council, staff, and citizens safe.

Mayor Hansen and Council discussed citizen response to East 12<sup>th</sup> St S & First Avenue No Right on Red Ordinance. It was suggested to make citizens aware of the safety reasons for this change.

Pursuant To The Provisions Of Section 21.5(1)(i), Code of Iowa 2021. AYES: Six. NAYS: None. Motion passed.

Upon return to open session at 8:59 p.m. it was moved by Trotter, seconded by Hallam to adjourn the meeting at 9:00 P.M. Motion unanimously carried by voice vote.
